1. Water Loss Update

Mr. Robertson reported there had been one leak fixed in Ballard. It was a pressure regulator in a meter box. Fixing the leak made a difference in water loss numbers at the water plant.

2. Status of Modifications to Wasterwater Plant-CI Thonburg Proposal

Nothing to report at this time.

3. Safety Meeting Update-

Porter reported they had two safety meetings since the last Board meeting.

4. Audit Update-

Whitney reported that Jared Gillespie from Lowe & Associates came down April 29, 2021 to gather needed information for the FY2020 Audit. Jared should have a draft submitted by the next regular meeting to be approved by the Board.

5. Engineering RFP- Little Rich Creek Valley Rd, Adair Rd, & Pinhook Rd Water Projects-

Mr. Belcher stated there were five engineering firms who submitted a bid on this project for RSPSD. Engineering firms interested in the work were: Dunn Engineering, Thompson & Litton, E.L. Robinson, Ghosh, L.A. Gates. The Board will review each bid an discuss at a later meeting.

6. Restricted Reserve Account Development-

Whitney had the Board sign all documentation for First Community Bank to open the account. She returned it to Dana at FCB with the \$120K check to deposit.

7. Wastewater Collection System Rehab Engineering Request for Proposals

8. Thrasher Engineering Invoice related to LRCVR and Adair Rd Response

The Board agreed to send Thrasher a letter written by Jason Ballard. (attached).

9. Revision on Personnel Handbook

Each Board Member was given a copy of the old RSPSD handbook and the current handbook. The Board is to review each handbook and discussion will be held at the next meeting.

10. Bridge Financing Discussion- Water and Wastewater

Until funding is in place, the District would essentially have to pay out of pocket or put the project on hold until monies are available. It is also an option to go to a bank and borrow money until funding is available and monies would be reimbursed

11. Wastewater Plant Maintenance Projects-UV and other

Porter is waiting to hear back on the UV bulbs at the wastewater plant that were wired incorrectly. He met with C2G at the UV to talk about getting a quote for the touchpad and PLC. They are capable of doing all the work. Mr. Roberson says there also needs to be a flow meter installed.

12. Permit Modification Request and H.A.M Landfill

Porter spoke with Cassie at H.A.M. Landfill about RSPSD installing a meter to monitor leachate. H.A.M. submitted a letter to the District asking to raise the limit of gallons used at the Landfill. At the moment we have a borrowed meter in there to determine quantity. Historically the landfill has supplied the meter for the facility.

1. Advertise for Term Engineering Services Related to Miscellaneous Water and Sewer Projects-5G

Jason Roberts responded back to Mr. Belcher that having an engineer firm on hand is a good idea for smaller jobs, but we would need to advertise for larger jobs.
